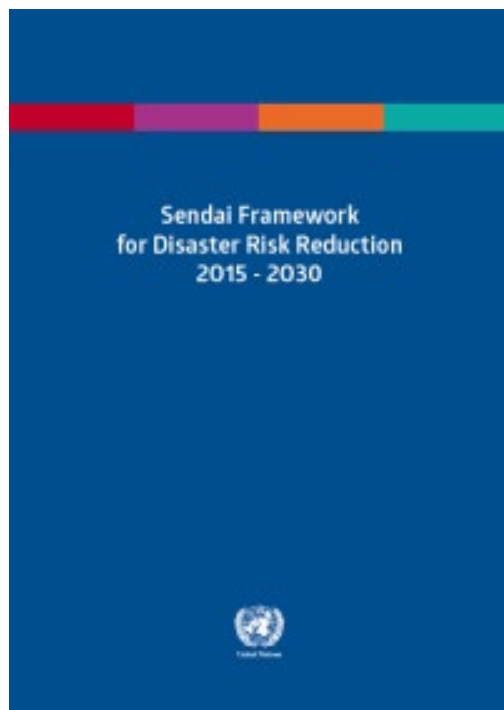

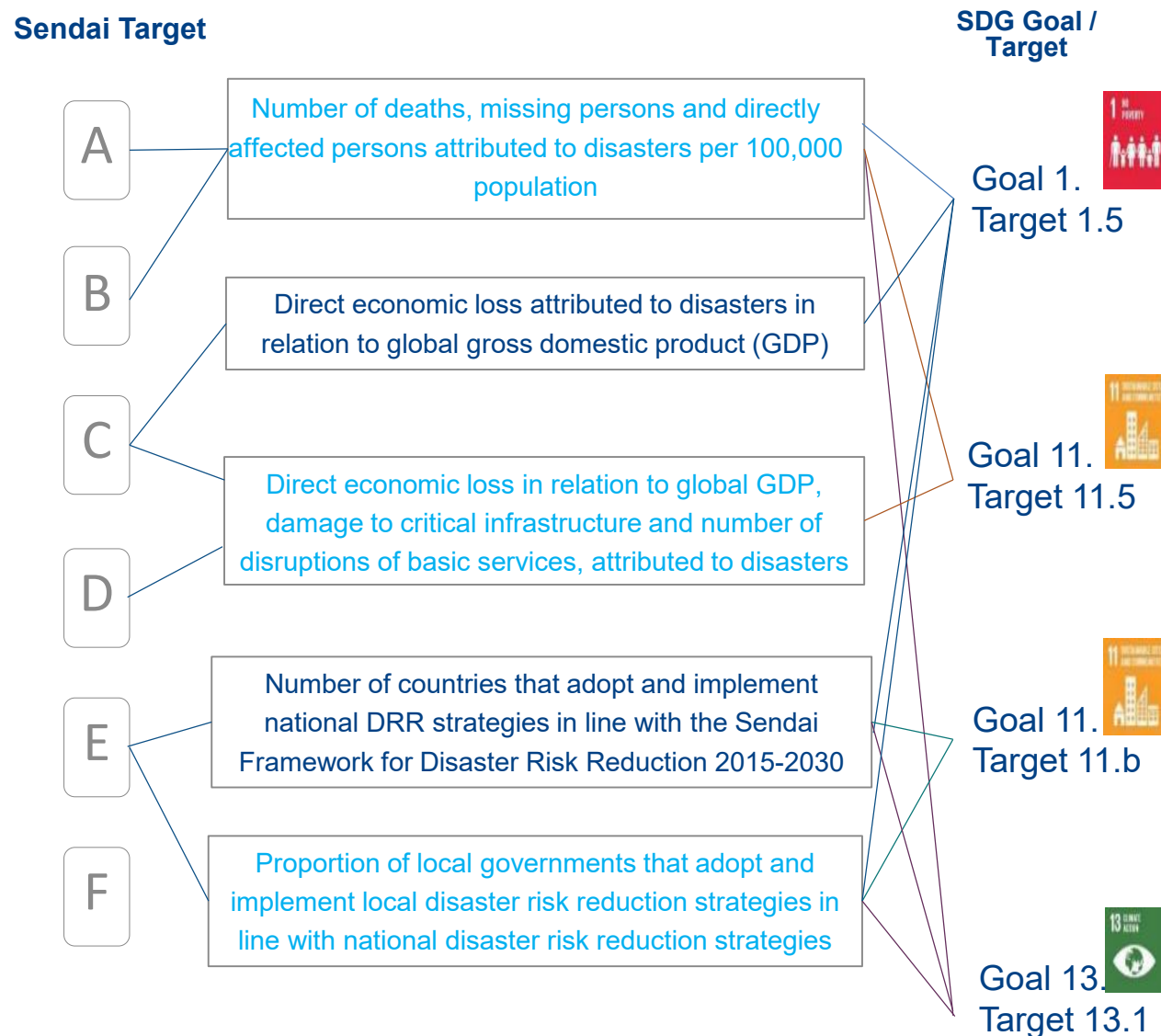

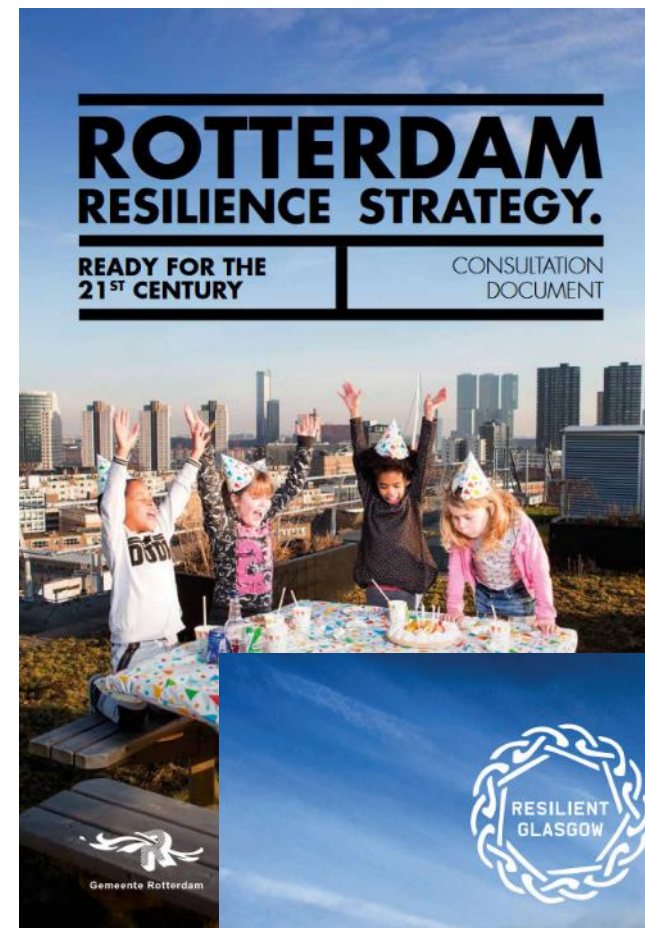
# Integrating DRR, Climate Adaptation and SDGs

- **Sendai Framework Monitor** provides a platform for reporting against Sendai targets and indicators, including at national level
- **City-to-city peer reviews** promote exchange of practices and mutual learning to - [methodology](#)
- **DRR Strategy assessments** are undertaken by UNDRR at the request of a country / city
- **Stress testing risk management capabilities** against emerging risk scenarios, such as climate and hybrid threat

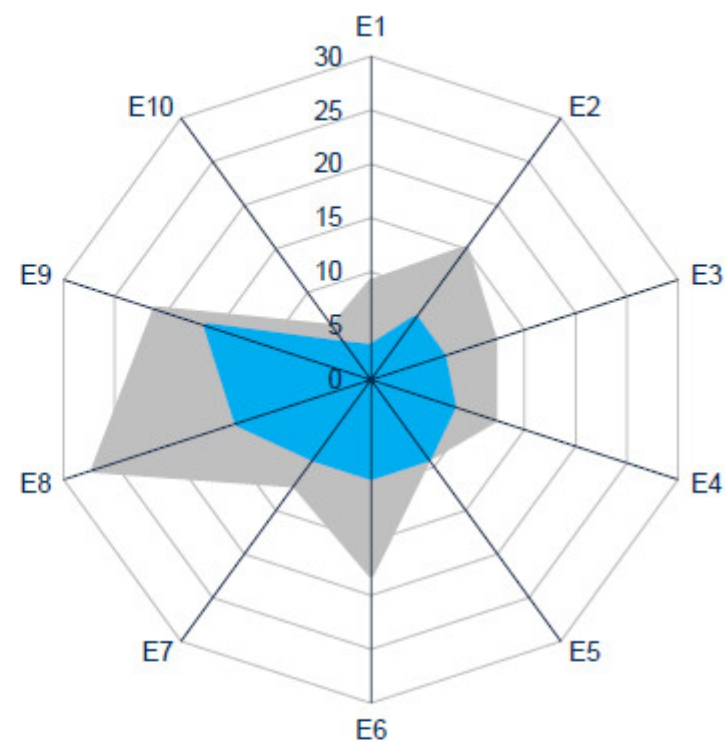

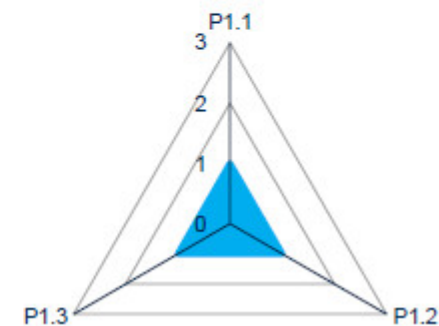

P1.3	Is resilience properly integrated with other key city functions / portfolios?	1





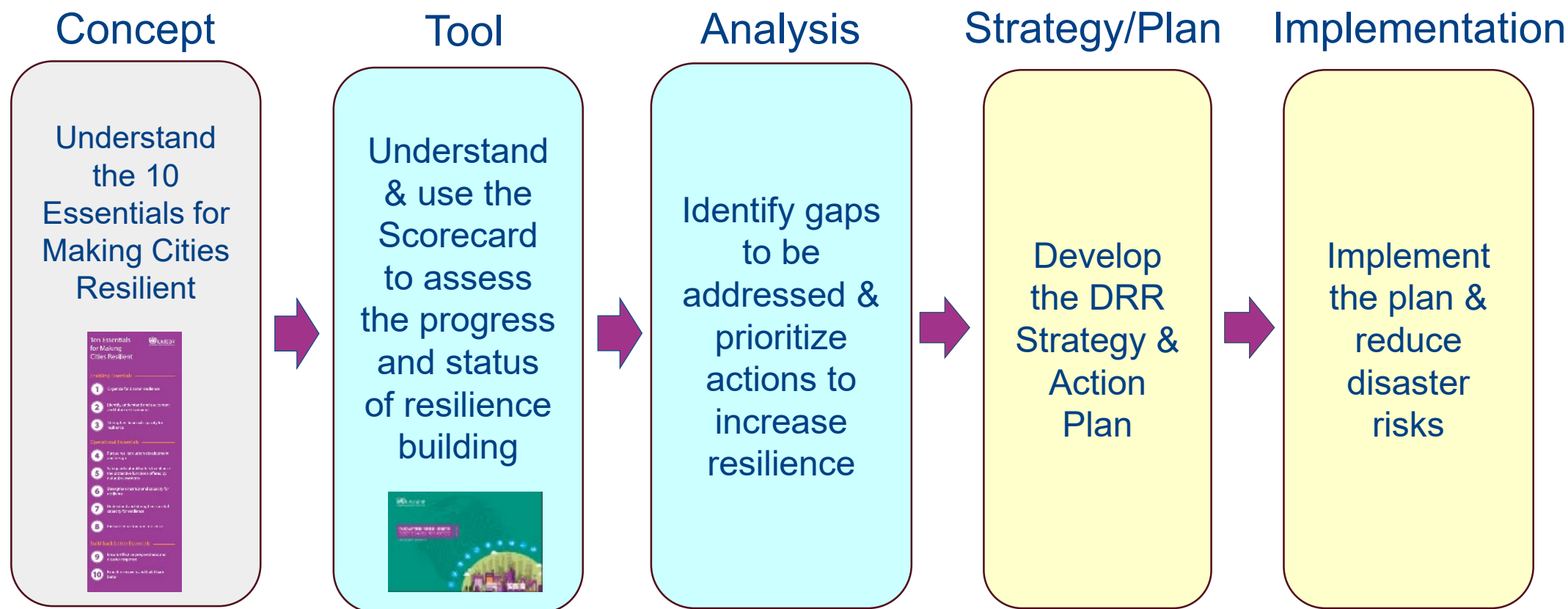
# Good practice: Greater Manchester
